Terms and Conditions of the Last Minute Shopping Market

1. Non-refundable

No refunds for cancellations and no-shows. Should you have to cancel your participation before November 1 every effort will be made to fill your table. If we are able to resell your space, you will receive a 50% refund. No refunds after November 1.



2. Sale Layout

The layout shall be as set out by the Organizer subject to the receipt of complete and approved Vendor Agreements and applicable fees.

3. Vendor Categories

Crafters & Artisans: those who can substantiate the claim they will themselves and by their own hand, create the goods intended for sale which must be substantially handcrafted.

Prepared Foods/Baked Goods Vendors: those who can substantiate the claim they will themselves and by their own hand, prepare the goods intended for sale.

All items intended for sale must be listed on the application. If you sell products that are not handmade, you will not be invited to return.

4. Set up and Sale Hours

Vendors will have access to the building from 9 am to 5 pm on Friday, December 6 for setting up their table(s). Vendors will be allowed in at 8 am on December 7. Vendors must be set up and ready by 9 am on the day of the sale and must remain open until the sale ends at 3 pm. A break room is available in the basement of the hall and will be for vendors only. Coffee and tea will be available but please bring your own lunch/snacks as nothing will be available. You cannot leave your table unattended. Please ensure you have someone cover for you if you need a break. Take down must not occur prior to 3 pm to be fair to all customers. Anyone who starts dismantling prior to 3 pm will not be permitted to attend future sales.

5. Waiting Lists

Those waiting for a vacancy must complete a vendor agreement and will be placed on a waiting list. Those with produce or goods not already represented will be given first right of refusal for all available vacant tables. Otherwise, tables will be offered by date of submission of a completed vendor agreement.

6. Guarantee/Warrantee

The Diocese of Huron, St. John the Divine, its Organizer or Council do not guarantee any sales results whatsoever of any vendor participating in the sale.
